



## 2018 Business Education Scholarship Application

This program is dedicated to provide scholarships to two graduating high school seniors who plan to study a business program at a college, university or vocational school. There are two scholarships offered: **Sam Campbell Memorial Scholarship:** One scholarship will be awarded in the amount of \$1,000. **Liberty Lake Rotary Scholarship:** One scholarship will be awarded in the amount of \$1,500. Scholarship will be awarded directly to the institution of choice after registration is confirmed for Fall 2018.

### Entry Requirements

1. Fill out the application completely.
2. Enclose a letter not longer than 500 words stating your interest in a scholarship.
3. Return the application and letter by the deadline date indicated at the bottom of your application.

### Award Process

1. Each entrant must be a Washington state resident enrolled in their senior year at a Greater Spokane Valley high school or completing equivalent studies (home school).
2. The scholarship awards will be selected by a panel unrelated to the applicants and will include members of the Sam Campbell family, Liberty Lake Rotary Club and Chamber Foundation.
3. All awards decisions of the panel are final and irrevocable. Should an award recipient not be able to use a scholarship, a runner-up will be selected.
4. The award will be presented to the scholarship winners at the Chamber's June 15 Business Connections Breakfast from 7-9:00 a.m. at CenterPlace Regional Event Center.
