



## ***2021 CTE Scholarship Application***

This program provides scholarships to graduating high school seniors, or other non-traditional students who plan to study a CTE program at a community college, trade, or vocational school. Scholarships will be awarded directly to the institution of choice after registration is confirmed. Students may reapply for funding each year; however, additional funding is not guaranteed and applications are treated as independent submissions.

### ***Entry & Eligibility Requirements***

1. Fill out the application completely.
2. Enclose a letter not longer than 500 words stating your interest in a scholarship.
3. Return the application and letter by the deadline date indicated at the bottom of your application.
4. Must be Washington Resident.
5. Enrolled in their senior year with path to Graduation or have recently graduated from one of the Greater Spokane Valley school districts including:
  - a. West Valley School District
  - b. East Valley School District
  - c. Central Valley School District
  - d. Freeman School District
  - e. Completion of Equivalent Studies from an – independent, private, or home school

### ***Award Process***

1. The scholarship applications will be reviewed upon receipt by a panel unrelated to the applicants and will include members of the Chamber Foundation. Our award process begins April 1 and completion of review on April 15. Applications will be accepted following April 1 annually and may receive an award depending on review and if remaining funding is available.
2. All awards decisions of the panel are final and irrevocable. Should an award recipient not be able to use a scholarship, a runner-up may be selected.
3. The award will be presented to the scholarship winners in writing as well as their selected institution.
