## The Network Guidelines

One participant per Network Group industry category.

If your category is filled, you can apply to another Network.

If all groups are filled for your category, you may choose to be waitlisted for your category.

Visitors must be approved by the Chamber before attending a group.

Network Group members must be members of the Greater Spokane Valley Chamber in good standing with your membership dues.

More than three absences per quarter will constitute removal from the group.

Group members are responsible for their own meeting logistics and costs.

A minimum of ten members is needed to create a new group. Groups will have a maximum of 20 members.

The Greater Spokane Valley Chamber will maintain a waiting list by group industry category.

A Network Chair is elected by Chamber staff for a term of one year. The Network Group will not accept applications from individuals that are members of other Network groups.
